CMBA will continue to monitor this evolving situation and make any necessary changes to our current plans to accommodate the best interest of health and wellness for our members.

April 21, 2020 MCLE MEETING

WHAT: "Assembly Bill 5 - The Attorneys' Full Employment Act of 2019"

WHEN: Tuesday, April 21, 2020, at 6:00 p.m.

HOW: much does it cost? \$60 members / \$70 nonmembers

WHY: Good food, good conversation and MCLE credit

At our April 21, 2020 meeting, CMBA Executive Director, Michael Fate, Esq., will provide our Members with an overview of California State Assembly Bill 5 (AB5), which expanded into many other areas of labor law the three-pronged test for independent contractors that had been adopted in wage and hours cases by the California Supreme Court in *Dynamex Operations West, Inc. v. Superior Court* (2018) 4 Cal.5th 903. This Act, which went into effect on January 1, 2020, affects millions of workers and employers in and beyond California and potentially may result in numerous civil actions and administrative proceedings. Mike will provide some background information about the Act, discuss its implementation, efforts to blunt its effects, and its many exclusions and will offer some thoughts about how it will be impacting your clients.

At our February MCLE dinner meeting, our speaker, Anthony Ching, Esq. enlightened our Members about the California Consumer Privacy Act (CCPA), the most consequential privacy law in the U.S. to date, which went into effect on February 1, 2020. We learned that, aside from creating expansive new consumer rights for California residents, CCPA will affect businesses based both inside and outside of California that handle "personal information" of California residents or business-to-consumer contacts, or that have California-based employees.

Our Board has been discussing ways in which CMBA can provide better service to our Members and to give Members more bang for their buck. One of the proposals being considered would be to cut down the number of our MCLE dinner meetings at Truxton's to five meetings rather than nine, with meetings in January, March, May, September and November, but having two speakers and two hours of MCLE credit at each of those meetings. That proposal would keep our admission prices approximately where they now are, so Members will get 10 hours of MCLE for about half the monthly price that they are presently paying for 9 hours of MCLE. We would appreciate our member's thoughts about this proposal and about any other matters that you feel can improve our Association.

We look forward to the coming year and plan to have interesting and educational speakers at our monthly MCLE meetings in April through June and In September through November, 2020. We also intend to have our summer barbecue in July, our joint mixer with The Esquire Network in August and our Holiday gettogether in December, so we expect to have a full and exciting year.

The Los Angeles Superior Court has asked CMBA to announce that the Court is recruiting for Temporary Judges. If any of our Members are looking to enhance their legal skills and to support the administration of justice in Los Angeles County, becoming a Temporary Judge is for them. The Los Angeles Superior Court will be conducting a mandatory Bench Conduct and Demeanor training on May 7, 2020. MCLE credit is provided for this training and pre-paid reservations should be received no later than May 1, 2020. This training is mandatory for any qualified attorney interested in sitting in Small Claims, Traffic, Family Law, Civil Harassment, Unlawful Detainers and Civil Collections.
